If MCC requests student or parent 2020 tax information to verify your 2022-2023 FAFSA. PLEASE go back to www.fafsa.gov and make a correction to the income section of your FAFSA using the "IRS link" to download your tax information.

If you are not able to use the FAFSA "IRS link", you must provide an IRS Tax Return Transcript or a signed copy of the tax return. Listed below are 4 ways to request an IRS Tax Return Transcript.

A 2020 IRS Tax Return Transcript may be obtained through the:

In most cases, for electronic tax return filers, 2020 IRS income tax return information is available for the IRS DRT or the IRS Tax Return Transcript within 2–3 weeks after the 2020 electronic IRS income tax return has been accepted by the IRS. Generally, for filers of 2020 paper IRS income tax returns, the 2020 IRS income tax return information is available for the IRS DRT or the IRS Tax Return Transcript within 8–11 weeks after the 2020 paper IRS income tax return has been received by the IRS. Contact the financial aid office if more information is needed about using the IRS DRT or obtaining an IRS Tax Return Transcript.

## Verification of 2020 IRS Non-filing Letter-

Provides proof that the IRS has no record of a filed Form 1040, 1040A or 1040EZ for the year you requested. It does not indicate whether you were required to file a return for that year. This letter is available after June 15th for the current tax year or anytime for the prior three tax years using Get Transcript Online or Form 4506-T. You must use Form 4506-T if you need a letter for tax years older than the prior three years.
