•	Get Transcript by Mail – Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and <b>NOT</b> the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.		
•	Get Transcript Online – Go to <a href="www.irs.gov">www.irs.gov</a> , click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and <b>NOT</b> the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or autoloan). The transcript displays online upon successful completion of the IRS's two-step authentication.
